INTRODUCTION

Uromi Justice Development Peace and Caritas Initiatives (Uromi JDPCI) through her wide-ranging streams of interventions promotes the integral development of the rural populace in Edo Central Senatorial District in accordance with her mission, which is to alleviate poverty and promote integral development through the motivation and empowerment of the less privileged/oppressed and challenging unjust structures that enhance injustice, hatred and backwardness in Nigeria. These interventions address challenges and norms around human rights protection, good governance, human trafficking and Irregular Migration, as well as interventions to promote healthy outcomes amongst children and families infected and affected by HIV/AIDS.

In her Human Rights Education and Paralegal scheme project, Uromi JDPCI conducted series of activities geared towards improving peaceful coexistence in the communities. Among which were Community Dialogue in 5 Communities, the facilitation of Adolescent Human Right Club Learning Sessions in 25 schools, the sensitization of representatives of 30 communities on Gender issues and Gender-based violence, training of paralegals and human rights advocates, and the conveyance of third Quarterly Meeting of Paralegals.

Uromi JDPCI also implemented some activities in collaboration with communities to strengthen good governance and encouraged community participation in governance for effective service delivery. The activities were: town hall meetings/media engagement, quarterly learning sessions, and monitoring visits to target communities.

In the anti-human trafficking desk, Uromi JDPCI trained and empowered 40 caregivers across communities in Edo Central Senatorial District. Five tertiary education students were also supported with grants for tuition fees. These were part of the Don't Pay With Your Life Project's effort to reduce susceptibility to human trafficking. Uromi JDPCI through the GATIP project also conducted some advocacy engagement meetings geared towards localizing trafficking in-person response at the LGAs in Edo State. Some public awareness events such as a rally to mark world day against human trafficking and the launching of campaign hashtags were also conducted

Uromi JDPCI through her Integrated Child Health and Social Service Award facilitated Operation Triple Zero (OTZ) Club Meetings for Adolescents Living With HIV/AIDS at Uromi Central Hospital and Irrua Specialist Teaching Hospital, the project also conducted community outreach for HTS as well as followed up on clients with unsuppressed viral load record.

Uromi JDPCI also sustained her micro-credit empowerment Scheme by providing soft loans to Small and Medium Scale enterprises and active farmers within the 5 Local Government Areas of Edo Central Senatorial District to enhance their businesses.

HUMAN RIGHT DESK HUMAN RIGHT EDUCATION AND PARALEGAL SCHEME

Quarterly Learning Sessions for School-Based Adolescent Human Right Clubs: The Six-quarter learning session with the Adolescent Human Right Club members was held in the months of September and October, 2022 in the selected 25 schools across the five Local Government Areas in Edo Central Senatorial District. The topic for the learning session was The Power of effective communication. The purpose of this topic was to improve their reporting skills when the incidence of abuse occurs so that proper actions could be taken. The content was focused on communication and the three types of communicators; (the confident communicator, the unconfident communicator, and the forceful communicator). At the end of the sessions, the students demonstrated an understanding of the various characteristics of the different communicators. The purpose of



this session was to build the capacity of the adolescent to effectively express themselves honestly, clearly, and respectfully and respect other people's opinions while standing by their principles, ensuring that their body languages match their words and they are thankful when they were praised. This was to emphasize the need to be confident while communicating incidences of abuse so that such matters could be easily followed. A total of 134 (53 Males, 81 Females) students were



reached. The students who participated in the learning session are already utilizing the knowledge to engage their peers in schools and communities to increase their awareness of child protection mechanism

Capacity Building (Training): A two-day training on the concept of human rights and constitutional rights, litigation, and procedure for the enforcement of human rights



in Nigeria was held on the 11^{th} and 12^{th} of July, 2022 at the Catholic Chancery Hall, Uromi. The purpose of the



training was to increase the knowledge of the participants on

human and constitutional rights and the procedure that is available to enforce human rights as well as the sections of the law that protects every person from abuse and violations of human rights. This was to better improve their capacity to effectively provide Paralegal services in their various communities as well as provide counsel to those in need of it.

In the course of the two days of training, facilitators took participants through a detailed and simplified discourse on human and constitutional rights through an interactive session with questions

tailored to prepare their minds for the impactful training and to ascertain their understanding and perception of Human Rights.

On day one, participants were taken through the pre- and post-colonial era of human rights in Nigeria,



the historical account of Human Rights in Nigeria which includes the military and civil dispensation and the limitations imposed under section 46 (1) of the constitution while presentations for day two centered on the application of the provisions of Chapter IV of the 1999 Constitution of the Federal Republic of Nigeria as amended which guarantees the rights of every citizen of Nigeria and the Perception of the society towards Human Rights Enforcement.

The participants thereafter expressed understanding of the developmental issues and human experiences that makes the concept of human right a continuous evolution since more classes of rights or more concept of the existing categories of rights may emerge. At the end of the training, the participants were better enlightened on their human and constitutional Rights. This was ascertained





from the well-informed questions and answers they provided to some technical questions and contributions regarding Litigation and Procedure for the Enforcement of Human Rights in Nigeria. A total of 130 (70 males, 60 females) participants were in attendance made up of 5 Seasoned Legal Practitioners who are the Supervisors of the 5 Local Government Areas of Edo Central Senatorial District

Quarterly Meeting of Paralegals and Human Rights Advocates: in this reporting period, a quarterly learning session for Paralegals was held between 21st and 27th of September, 2022, with a total of 300 persons-(Males 144 and Females 156) in attendance. In the opening remark, The Executive Director appreciated the resilience of the paralegals and human right advocates and despite the challenges encountered in the cause of carrying out their intervention, he exulted them not to relent but to look at the aftermath of their good works in the communities as a motivating factor in continuing their activities. He told them that if they remained focused, their effort would yield bountiful results in the future.

Key activities reported were community sensitizations carried out by the advocates on the promotion of rights of community members, especially female, interventions carried out in cases of child abuse, neglects, spousal abandonment, and the like as well as ensuring due process in enforcing justice on human right violations which were criminal in nature. In the course of giving the reports, challenges faced by the Paralegals and Advocates were also deliberated upon. The Paralegals and Human Rights Advocates in the various communities used the opportunity to share their knowledge, experiences, challenges, and plans for their various communities. Some coaching and mentorship were also given by the Executive

the



meetings during which their zest in ensuring that

community members felt their presence through their activities and interventions was appreciated. The project team expressed joy over the manner in which community members sought the interventions of the Paralegals and their abilities to amicably resolve disputes through Alternative Dispute Resolution Mechanism. Their efforts in ensuring the protection of human rights in their



various



communities was also appreciated. Those who were undergoing challenges in the quest to carry out



human right activities were encouraged to be relentless, reminding them that a journey of a thousand miles began with a step and therefore, the expected behavioral changes in the community would only take place if they were consistent in their dealings and engagements. Also noted, was the challenge in intervening in cases related to abandoned children as shelters to serve as alternative settlement for such children who have undergone abuses from persons they were

living with were not available at the Senatorial District and the State in general. That notwithstanding, the project team used the opportunity to counsel the advocates on the need to be swift during intervention so as not to cause miscarriage of justice as a result of undue delay and the like.

Community Dialogue: 10 community dialogues were held within this reporting period. Uromi JDPCI carried out Community Dialogue in Egbele, Uhe, Ahia, Ukpenu, Idumebo, Ogwa, Eguare-Igueben, Ivue, Emu, and Emaudo Communities between April 2022 and September 2022, to discourse on human rights issues with emphasis on Child protection/rights and widowhood practices, human right issues peculiar to the various



communities and the way forward. The participants were made up of traditional rulers, chiefs, community leaders, men, women, and youths in the various community and the project team as well



as the supervisor of the human right clubs in various Local Government Areas. The dialogues which were held at the traditional rulers' premises, residences of community leaders, and community halls/squares had reasonable resolutions to improve the participation of women in social-cultural, and economic issues as well as liberating them from cultural hegemony. Some communities began the discussion to abolish certain cultural practices that reduce women to mere possessions and subject women to inhuman treatment in the guise of customs, tradition, and religion. A total of 220 persons made up of 137 males and 87 females were reached In all the communities, there was no clear definition of a child in terms of age, but after the dialogue, the participants agreed that any person who was below the age of 18 is a child as such community members should makes effort to protect all children from abuses and violence. Some participants cited the need for community structure to be put in place to ensure the protection of the rights of children especially their right to education.

On the aspect of widowhood practice, community members stated that widowhood practices were matter of cultural beliefs that will require critical thought. However, they agreed that ill treatment constitute violation against the victims' rights and that not all widowhood practices constitute ill treatment as such the part that constitute ill treatment should be reviewed and abolished. Some communities listed examples of ill treatment that have been abolished because they violate the widows right to social relation by isolating her and subjecting



her to confinement in a small room where she was met to sleep on the floor for some period of days, eat with unwashed dishes and hands made to put on one attire throughout this period and being



faced with accusation or suspicion of killing her husband. She was therefore made to swear an oath to prove her innocence and get inherited by any surviving male family member of her deceased husband. They noted that out of the aforementioned practices, all of them had gone on extinction, except the act of widow inheritance and that it would be important to critically consider the rights and consent of the widows in such cultural practices. This is still being resisted by some communities due to their conservative attitudes and fear of repercussion.

Gender Sensitization: Uromi JDPCI conducted annual



sensitization on gender issues across the 5 LGAs. The focus was on the Rights of Females to Inheritance and the rights to freedom of Religion. The purpose was to



critically evaluate the ideas and practices upheld by the people, with a view to determining which ones are adequate and in line with the promotion of human rights and which are erroneous. The primogeniture rule of inheritance as practiced by the Esan people, is an undeniable phenomenon in virtually all communities in Edo Central Senatorial District, though the severity varies from one community to another. This act of discrimination against the female sex, has become an unquestionable act in virtually every community in Esan Land. Esan people, fashioned a pattern of inheritance according to the rule of primogeniture. This rule was predicated upon some ideas which were relevant at that time of formulation where the first son held properties in trust for other members of the family and remained in his father's house as the head of the family while the Female Child was not given a place as a person with rights; rather, she was objectified as an inheritable item both in her parental and marital families. However, there is no gain saying that the rule has become irrelevant since modernization and civilization has made communal living impossible, as most first sons do not even remain in their fathers' house or village localities and most importantly, the need for the promotion of the human rights of all. More so, the implementation of religious right within the district has become a no success situation because of the modulation of religion into the custom and tradition of the people, hence some religious rites are often expected from the heir of the deceased before properties could be legitimately transferred. Failure to perform such religious rite would lead to the loss of the right to inheritance by the heir. The facilitator distinguished cultural practices from



religious practices and tradition. Here participants were able to interactively see that they erroneously submerged the way of life of the people with religious belief in their



practices. For instance, there exist the customary practice of presenting a goat for sacrifice while performing the burial rite and even as part of the mourning act of the widow in some cases; and where such acts were challenged by the duty bearers due to negation of their own religious practices, they risked discrimination and isolation from community members. The facilitator laid emphasis on the fact that freedom of religion was constitutionally guaranteed while buttressing that no community had the power to take away a person's freedom of religion under the guise of cultural or traditional practices. Here, participants understood how some demands could lead to the violation of the freedom of religion of persons especially women who were mostly victims of customary enactments and therefore admitted that low knowledge in the differences between culture, religion and tradition had led to the promotion of unjust, unfair and unequitable practices in the community. They therefore saw the need to consciously address these issues in the community for change. Participants conversed on key issues on Esan concept of inheritance, the right of women to inherit their father's properties, the Esan people's standpoint on religion, culture, and tradition as well as participants' perception on justice, equity, and fairness.

The sensitization was held across the 5 Local Government Areas of Edo Central Senatorial District from the $15^{th} - 19^{th}$ of August 2022 with a total of 525 persons (305males, 220females) reached. The participants comprised relevant community stakeholders with influential charism and power to amend, modify and change certain customary laws in force that enhance such inequalities in their communities.

GOOD GOVERNANCE

Community Mobilization and Engagement for Transparency, Accountability and effective service delivery

Town Hall Meeting/Media Engagement

Uromi JDPCI conducted town hall meetings and media engagement sessions on community participation in governance for effective service delivery. This was part of the efforts to improve community participation in ______ governance for accountability, transparency, and





effective service delivery. The purpose was to increase

awareness among stakeholders on the relevance of community participation in governance and their roles to improve effective service delivery to their communities as well as engage the media to reach out to the government on the governance demand of the grassroots level and the result of their effort in reaching the Local Government representatives. This was achieved through the town hall meeting that brought stakeholders and civic groups from 25 communities together to reflect on local government service delivery in their communities.

Present at the event were the supervisors and civic group members of the 25 community civic groups instituted across the 5 Local Government Areas in Edo Central Senatorial District, Gentle Men of the press which include; Popular News 9ja of Benin City Edo-State, Grassroot Television Benin City, Edo State, The Observer Newspaper of Benin City Edo-State, representative of the Nigerian Union of Journalist, Independent Television of Benin City Edo-State, News Curve of Benin City Edo State, Navigator Newspaper of Benin City Edo-State and Esan Binocular of Uromi Edo-State. A total of 61 persons (38Male, 33 Females) were present

In his press release, the Executive Director of Uromi JDPCI Very Rev Fr Dr. Fidelis Arhedo called on the





Local Government Acting Chairmen to be responsive and accessible to the local people and consider community input in the delivery of services to the communities. He also called on the Ministry of Local Government Affairs being the coordinating Ministry to approve and mandate LGAs to make accessible the approved LGA budget to the community groups as part of their commitment to promote Open Government Partnership. He also appreciated the commitment of the Edo- State government in encouraging such a transparent and accountable approach to governance. He thereafter requested the Governor to see to the fact that same was implemented at the grass root level. He also advised participants and the general public to focus on issues that would lift Nigeria and Nigerians from the current political administration's malady as they decide their choices in the coming 2023 general election.

Quarterly Learning and Experience Sharing Session

Uromi JDPCI had the second quarterly learning and experience-sharing sessions with the civic group members across the 5 LGAs in Edo Central Senatorial District. The sessions were held in the month of August 2022.

This was part of the effort to build the capacity of local people for improved community participation in governance to ensure accountability, transparency, and effective service delivery in the Edo Central Senatorial District communities.

The meeting provided a platform for experience and knowledge sharing amongst the civic groups in actualizing their set goals. It was also an avenue to learn about their achievements and performances, discover their challenges,



and deliberate on possible solutions to such challenges. The sessions also serve as a platform for engagement which is helping them to learn from the experiences of others and strengthen Synergy among the various groups for improved collaboration and sustainability and thus improving their confidence to engage representatives as a group of communities affected by the common good rather than as an individual community. A total of 228 persons (129Males, 99Females) participated in the meetings.

Monitoring Visits to Civic Groups in the 5 Local Government Areas

The project carried out quarterly monitoring visits to the established civic groups across the 5 Project Local Government Areas in Edo Central Senatorial District. This was to provide mentorship for the effective functioning of the groups, render technical support in addressing identified gaps and challenges and also

ascertain the extent of the groups' engagement with their community representatives in harvesting the gains



of democracy and achieving the overall objective of the project. This activity took place between July and August 2022. The various groups were visited during their monthly meetings. Some of the issues discussed were community self-help activities such as clearing the community roads and drainages, others were the outcome of the engagement with the representative including the attitudes of their acting chairmen which do not portray any form of local government autonomy or capacity to cause a change in their communities. They resolved to pass a strong message through the media to the state

Governor to caution the acting chairmen to be responsive to the needs of the local people rather than ask them to write to Benin City for ordinary issues that the Local Government should be able to address. Some groups also took time to inspect the government projects that were being implemented in their communities to be sure they were being implemented according to specifications.

ANTI-HUMAN TRAFFICKING

Don't Pay With Your Life (DPWYL)

UROMI Justice Development Peace and Caritas Initiatives (Uromi JDPCI) in her Partnership with ECPAT France and ECPAT Luxemburg to prevent the susceptibility of adolescent girls and young women from Edo State to Human trafficking and sexual exploitation via the Don't Pay With Your Life project implemented several household economic strengthening activities for vulnerable children as well as reintegration support for Survivors of human trafficking with the ultimate goal of reducing their vulnerability to human trafficking. These activities include; Entrepreneurial Reawakening Training centred on Financial Management and Savings for (40) Caregivers and (10) Young Female Returnees as well as Economic Support to strengthen the business activities of the Caregivers and Returnees, Tertiary education Support for (3) students in vulnerable families and Enrolment into apprenticeship program for (13) of the supported students who have completed their secondary education and have the willingness to learn a vocational skill. Group discussion sessions were also held with the Caregivers and Returnees.

Entrepreneurial Reawaking Training on Financial Management and Savings for (40) Caregivers

Uromi JDPCI facilitated a one-day entrepreneurial reawakening Training centred around Financial Management and Savings for (40) Caregivers of the Don't Pay With Your Life Project who are active in business. The training was held at the Catholic Chancery Hall, Egbele, Uromi on the 4th of August 2022 to improve participants' knowledge of financial management and savings for the sustainability of their business and in ways that lead to improvements in the livelihood and well-being of their families.

Participants were taken through various concepts such as the meaning and relevance of financial education, Financial Management, budgeting, understanding income and expenditure, bookkeeping, and the need to save to meet future needs and expand their business capital.

The participatant who became better equipped to effectively manage their businesses expressed satisfaction and appreciation for the knowledge passed to them and promised to imbibe lessons learnt to advance their businesses and increase their income for the overall improvement of their household livelihood

In the course of the training, Participants came to realize the need to manage their finances in ways that are efficient to avoid business breakdown. Through the knowledge gained, they expressed a renewed commitment to their businesses, especially in the area of record keeping, and increasing their savings by joining savings groups to access more business capital.

Economic Support to Vulnerable Families and Young Female Returnees

Uromi JDPCI on Tuesday the 16th of August 2022 supported 40 of her previously reached caregivers who demonstrated a high sense of commitment and dedication to their businesses with the sum of N50,000 each

supported by the project, were also provided additional work materials/goods to the tune of $\frac{1}{100}$, 000 each as support to strengthen their life skills.

More so, three children in the tertiary institution received educational scholarship of N200, 000 (two hundred thousand naira) each to support their educational endeavours, while 13 (thirteen) beneficiaries who have completed their secondary education were also enrolled as apprentices in vocational training centers.



Sixth Group Discussion Session With Caregivers On Better Parenting

Uromi JDPCI conducted the sixth phase of the group discussion session with Caregivers of the "Don't Pay With Your Life" (DPWYL) project on the Responsibility of Caregivers in Preventing Human/Child Trafficking. The session was held at the Chancery Hall, Uromi, Edo State with a total of 40 Caregivers, all females in attendance.

The Executive Director of Uromi JDPCI Very Rev. Fr. Dr Fidelis Arhedo, admonished the Caregivers to maximize the objectives of the session which is aimed at building their capacity to better understand the ills of human trafficking/Child trafficking and open them up to their responsibilities in protecting their children from trafficking situations. He also advised the caregivers to strive at becoming more productive and resilient in the various businesses the project has helped them establish so they can be in positions to continually support their children.

This was followed by an interactive session with the participants during which some of them gave feedback on the results obtained from the application of lessons learnt from the previous group discussion.

The Caregivers were sensitized on their Responsibilities in Preventing Child Trafficking which include but not limited to: being cautious of offers that are too good to be true from people including relatives. Investigating properly those who come to them offering to help their children. Making adequate provision for the family, spending quality time with their children, showing love, and being an embodiment of trust to their children.

Furthermore, they were told to invest in their children and give them quality education, noting that every child must attain at minimum the Senior Secondary School Certificate Examination, and if they do not have the means to take them to tertiary institution, they should encourage them to acquire a vocational skill and always ensure to monitor their progress. Lastly, they were told to report suspected cases of human trafficking to NAPTIP, Edo State Taskforce Against Human Trafficking, Uromi JDPCI etc.

At the end of the discussion session; an interactive session

They were thereafter appreciated for the commitment expressed in supporting the intervention while relating that they would always be invited to participate in the community dialogue sessions and other community activities planned in the project.

Commemoration of World Day Against Trafficking in Persons Held on the 30th July 2022 across the Three Senatorial Districts of Edo State (Uromi, Auch, and Benin City)

The localizing trafficking in-person response (LOTIP-R) cluster made up of Uromi Justice Development Peace and Caritas Initiatives (Uromi JDPCI), Josemaria Escriva Foundation (JOSEF), Girls Power Initiative (GPI), Ideal Development and Resource Centre (IDRC), Willi Johnson Foundation (WJF), Justice Development and Peace Commission (JDPC) Auchi and Edo State Taskforce Against Human Trafficking (ETAHT) on Saturday, 30th of July 2022 marked the World day against Human Trafficking with a rally procession across the three Senatorial Districts of Edo State (Uromi, Benin and Auchi). The rally was part of the Strengthening Civic Advocacy and Local Engagement (SCALE) Nigeria Project sponsored by USAID. The purpose was to create awareness and sensitize the people about the dangers of human trafficking and irregular migration. The sensitization emphasized the need to be conscious of the use of technology in travel preparations to avoid traffickers who also use technology to recruit unsuspecting persons. The rally also featured the distribution of handbills and postcards with various inscriptions deduced from the theme of the commemoration: "Use and Abuse of Technology" while public address systems were used to address the people at strategic locations like the market, junctions, and busy/highly populated shops or business complex.

Attendance at the rally recorded 328 persons, 137 males and 191 females across the three locations of which youths' participants were 181 while the other participants were 147.

attendance. A total of 113 persons (37 males and 76 females) ^{at} participated in the rally.

The procession started from Edo State Taskforce against Human Trafficking office with a walk through City center: Airport road, Ring road, Mission road, Ibiwe by Oba market and was concluded with a visit to NUJ center where the team was received by the NUJ Chair Mr. Festus Alenkhe who promised to spread the message through their various channels so as to prevent youth from falling prey to traffickers who adopt the use of technology to recruit their victims.

In Auchi, Edo North Senatorial District, the rally/road walk which was anchored by LOTIP-R cluster members in Edo North (Willi Johnson Foundation and JDPC Auchi) started from Immaculate Conception Cathedral Gate through AP Junction to Jattu Junction and beyond. The main purpose of the rally was to create awareness/ sensitize the people on the safe use of internet and social media that could help mitigate the risk of people falling victim of trafficking online. A representative of the Acting Chairman of Etsako West Local Government Area and the Head of Social Welfare department joined in the rally. A total of 108 persons (44

Josemaria Escriva Foundation commenced from St Anthony Cathedral through Mission road with a stop at the Uromi main market, Udo lane and Oyomoh street. After which the rally was concluded at the Cathedral where it first started. The Team stressed the need to travel regularly, having the right information of one's travel destination and being mindful of travel opportunities in the internet as Traffickers now also utilize online platforms to get their victims. Members of the Great Esan Returnees Association (GERA) also used their trafficking experiences to sensitize people on the dangers of human Trafficking. A total of 107 persons (56 males and 51 females) participated in the rally.

In all of the three locations LOTIP- R cluster emphasized that it is the duty of us all to strive, fight and work to reduce human trafficking as much as possible in Edo

The targeted audiences were therefore encouraged not be victims of the traffickers' plot as well as called on the Government, NAPTIP, ETAHT, law enforcement agencies, the criminal justice systems and others to leverage on technology in their responses, including enhancing prosecutions through digital evidence and providing support services to survivors, while Awareness-raising activities on the safe use of the internet and social media as well as cooperation with the private sector to support prevention and combatting of human trafficking be enhanced.

Strategic Advocacy Engagement Meeting with The Commissioner for Justice and Attorney General of Edo State held on Tuesday 9th of August 2022

The Localizing Trafficking in Persons Response Cluster (LOTIP-R) made four strategic advocacy engagement meetings with key decision makers and influencers in Edo State Government to sue for their support and collaboration towards the legislative review of the Edo TIP Prohibition Law 2018 to institutionalize and activate Trafficking in Persons Response at the Local Government levels of Edo State. The stakeholders visited were the Speaker of Edo State House of Assembly, his deputy, Chief Whip and the Hon Commissioner for Justice/Attorney General of the State.

The Attorney General, Hon Oluwole Iyamu SAN noted that the review was in process and a whole-scale restructuring was ongoing. He noted that what necessitated the overhauling was the feedback from

support the process. He assured the Cluster of the Assembly's readiness to partner with the Team to see that the proposals come to fruition.



In the remarks, the Executive Director, Uromi JDPCI, Very Rev. Fr. Dr. Fidelis Arhedo noted that the event was put together to launch the advocacy campaign hashtags for the project "Galvanize Action for Effective Trafficking in Persons Response at the LGAs of Edo State". While giving an overview of the SCALE project Technical Advisor, Social Protection and Inclusion, Nigeria SCALE Mr. Eric Umoru explained that the SCALE project implemented by Palladium with support from USAID seeks to strengthen the capacity of Civil Society Organisations to push for reforms and demand for accountability in different sectors including Countering Trafficking in Persons, good governance, anti-corruption and issues around sexual and gender-based violence.

A total of 864 persons were screened, yielding a total of 2 reactive persons (an adult and a child) who were confirmed positive and linked to treatment and care

Visit to Virally Unsuppressed CLHIV

With regards to contributing to the 3rd 95 UNAIDS goal, 15 virally unsuppressed CLHIV residents within Edo central senatorial district were traced to their homes and schools, while others were tracked via phone calls within the reporting period; this was done in order to provide community-based adherence counselling while ensuring they are linked to EAC and thus complete it.

The visit was also to identify the principal causes of the viral load unsuppression amongst the CLHIV related to financial/economic challenges and as such prioritized such households for financial literacy, linkages to VSLA, and other household strengthening interventions.

ARFH ICHASSA 2 Project Review Meeting

In order to reflect on key achievements, success stories, best practices, lessons learnt, and challenges encountered during the Fiscal Year 2022 (FY22), ARFH-ICHSSA 2 project had a 2-day Annual Review Meeting at Dover Hotel, Ikeja with partners in Lagos and Edo states. The meeting also featured the progress report from the Strategic Information department, financial review update and system strengthening efforts as well as effective strategies for FY 23 project implementation. Apart from Lagos and Edo states partners, also present at the meeting were her consortium partners FHI360 and Project HOPE. A total number of 58 participants were present.

MICRO CREDIT DESK

Uromi JDPCI has continued to empower small-scale enterprises and active farmers within Edo Central Senatorial District through her micro-credit scheme which provides soft loans for economic development to farmers and petty traders. Soft loans are given to groups of women and men who are active in business and small-scale commercial agricultural activities to enable them to boost their business which would ultimately lead to an improvement in their livelihood conditions. The Scheme has empowered over 1631 persons across 140 groups with 69 active groups currently in place.

Within the period, thirty-one (31) groups, were visited for collections and mentorship in communities across the five LGAs in Edo Central Senatorial District. Eighteen (18) groups were also given training to prepare them for empowerment in the scheme. The Micro Credit officer while appreciating the members of the group for their commitment in meeting up with the six (6) months repayment provision of the scheme, restated the need for all the members to remain committed as the money they would get will be greater than the cycle they just concluded because they have demonstrated resilience and commitment to their business and the repayment process.



The members of the groups expressed readiness to obtain higher support as they pledged their commitment to



the process. They were thereafter given another round of

soft loans to boast their business and agricultural activities through bank transfer.

INSTITUTIONAL STRENGTHENING

3-Days Workshop on Sustainability and Resource Diversification Organised By Palladium SCALE For Anchors Organizations From The 5th- 7th of July 2022.

As part of the SCALE Project capacity-building interventions, Uromi JDPCI Participated in the Sustainability and Resource Diversification Workshop organized by PALLADIUM SCALE at Hawthorn Suites Abuja. The training exposed Participants to various Resource Mobilization Strategies for increased fundraising for organizations and ensuring the sustainability of their interventions to their target populations. A major output

from the training was the co-creation of a 5 year resource mobilization / business plan by the various Anchor Organizations. Thus Uromi JDPCI now has an operational resource mobilization strategy. The training was attended by 15 participants from 5 different Anchor Organizations; which include CAJA (Centre for Awareness and Justice Accountability), ICD (Initiative for Community Development), WFI (Women Friendly Initiative), the Order Paper, and Uromi JDPCI.



The sessions were facilitated by Dr. ThankGod Okosun from Palladium (Technical Advisor Organizational Development) and involved handholding, brain-warming exercises and group presentations.

Uromi JDPCI participated in a one day capacity building workshop on Private Sector Engagement Organised by Palladuim SCALE through her resource Partner, ACIOE Associates. The workshop was held at Royal Continental Hotel and Apartment Abuja on the 18th of July, 2022. It was aimed at sharpening the skills and capacities of Civil Society Organisations (CSOs) on the strategies of engagement with the private Sector whilst promoting better understanding of the role of the private Sector in program sustainability, and areas of CSOs collaboration with the Private Sector. The workshop was attended by 12 participants- 5 Males and 7 Females from four different anchor Organisations namely; Centre for Awareness and Justice Accountability, Women Friendly Initiative, the Order Paper, and Uromi JDPCI. A major deliverable from the workshop, was the development of a draft Private Sector Engagement Strategy by the Participating Organisations.

Organisational Capacity Assessment (OCA)/ Organisational Performance Index (OPI) Assessment


As part of the interventions of the SCALE project targeted at improving CSO Organisational Capacity, Uromi JDPCI on the 21st and 22nd of September, 2022, underwent a tailored capacity building assessment which was conducted by WEWE (Widows and Orphans) Foundations; using the OCA and OPI tools. The OCA measured the Organisation at the outcome level; looking at the systems

and policies available and operational within the organization across 12 domains which include; Leadership and Governance, System and structures, Human Resource, Administration, Organisational Management, Resource Mobilisation, Project Performance Management, Gender and Social Inclusion, Monitoring and Evaluation Research and Learning, External Relation, Financial Management and Procurement while the OPI measured the impact of the
